

**THE VALE OF GLAMORGAN COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND
LOADING AND PARKING PLACES)**

(CIVIL ENFORCEMENT) (AMENDMENT) (NO 11) ORDER 2022

1. Notice is given that the Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers proposes to make an Order to install and amend the parking restrictions specified in the Schedules below.
2. 3. Persons objecting to the proposed Order are advised that in view of the Local Government (Access to Information) Act 1985 this Council is legally obliged to make any comments received in response to the proposed Order open to public inspection.

The following Traffic Regulation Order is to be amended as follows:

SCHEDULE

Map Schedules AX43 and AW43

Proposed Prohibition of Waiting At Any Time

Unnamed Road leading to Cardiff Airport Business Park, Rhoose

1. On the northwest side from the junction with the Unnamed Road that leads to Barry College Training Centre, in a north easterly direction for a distance of approximately 103 metres.
2. On the northwest side from the junction with the access road into DNATA Catering, in a generally north easterly then south easterly then south westerly direction for a distance of approximately 169 metres.
3. On the southeast side from unnamed road leading to Porthkerry Road, in a north easterly direction for a distance of approximately 60 metres.

Access Road leading into DNATA Catering

4. On the southwest side from the junction with the unnamed road fronting Cardiff Airport Business Park in a north westerly direction for a distance of 19 metres.
5. On the northeast side from the junction with the unnamed road fronting Cardiff Airport Business Park in a north westerly direction for a distance of 17 metres.

Access Road leading in Aircraft Tool Hire

6. On both sides from the junction with the unnamed road fronting Cardiff Airport Business Park in a south easterly direction for a distance of 10 metres
- Unnamed Road leading to Barry College Training Centre, Rhoose**
7. On northeast side from the junction with the Airport Business Park roundabout in a north westerly direction for a distance of 30 metres.
 8. On the southwest side from the centre point of the junction with the unnamed road leading to Cardiff Airport terminal building, in a north westerly direction for a distance of approximately 54 metres.

Unnamed Road leading to Porthkerry Road, Rhoose

9. On both sides from the junction with the Airport Business Park roundabout in a south easterly direction for a distance of 13 metres.
