**THE VALE OF GLAMORGAN COUNCIL  
(WENVOE PUBLIC FOOTPATH Nos 25 & 56)  
(TEMPORARY CLOSURE) ORDER 2022**

On the 7<sup>th</sup> February 2022 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984, made an Order as described in the schedules below:

The Order shall come into force on 14<sup>th</sup> February 2022 and will be known as "The Vale of Glamorgan Council Wenvoe Public Footpath Nos 25 & 56 (Temporary Closure) Order 2022. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 14<sup>th</sup> February 2022 apply to the High Court for this purpose

**SCHEDULE 1**

No person shall proceed on foot in the locations specified in Schedule 2 below.

**SCHEDULE 2**

<b>Location</b>	Footpath (Public Rights of Way) known as Wenvoe Numbers 25 & 56 from Grid Ref ST 11599 73240 to Grid Ref ST 11664 73290 at Whitehall Farm St Lythans, Wenvoe
<b>Alt. Route</b>	During this closure there will be signed diversions in place.
<b>Reason</b>	To prevent danger to pedestrians while demolition & reconstruction work is carried out.
<b>Duration</b>	From 08.00 on Monday 14 <sup>th</sup> February 2022 for a maximum period of six Months or until the works are completed whichever is the earlier.
