(A48 BROCASTELL) (CYFYNGIAD CYFLYMDER 30MYA)
(DROS DRO) (RHIF 2) 2022**

**THE VALE OF GLAMORGAN COUNCIL
(A48 BROCASTLE) (30MPH SPEED RESTRICTION)
(TEMPORARY) ORDER (No2) 2022**

On the 18th August 2022 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers made an Order the general effect of which is as described in the Schedules below.

The Order will come into operation on the 28th August 2022 or on the date that the necessary Traffic Signs are in place whichever is the later. A copy of the Order and plans showing the affected area may be inspected on the Council's website at www.valeofglamorgan.gov.uk If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 28th August 2022 apply to the High Court for this purpose.

SCHEDULE 1

The following Permanent Traffic Order shall be suspended, in part, for the duration of this Temporary Traffic Order:

The Vale of Glamorgan Council (A48 Brocastle) Extension of 40mph Speed Restriction Order 2004

SCHEDULE 2

No person shall cause or permit a motor vehicle to proceed at a speed greater than 30 miles per hour between the locations specified in Schedule 3 below:

SCHEDULE 3

- Location:** The section of A48 Brocastle from the junction of Corntown Road to the junction of Keeper's Lodge Bridge over river at the Vale County Boundary.
- Reason:** The restriction is being implemented to allow highway construction works to take place.
- Duration:** From 7.30am on 28th August 2022 for a maximum period of 6 months or until the works are completed whichever is the earlier.
