**VALE OF GLAMORGAN SHOW
WEDNESDAY 10th AUGUST 2022**

NOTICE IS HEREBY GIVEN that the Vale of Glamorgan Council have made an order under Section 16A Road Traffic Regulation Act 1984 as follows:-
WHEREAS during certain hours of the day and dates specified in column 1 of Schedule 1 hereto the streets or part thereof listed in column 2 of the said schedule will be used for the holding of a relevant event as described in Section 16(A)(1) of the Road Traffic Regulation Act 1984, the Council, pursuant to the powers conferred by Section 16A of the Road Traffic Regulation Act 1984 do **HEREBY ORDER AND DIRECT** in order to facilitate the holding of the event, enable members of the public to watch the said event and to reduce the disruption to traffic likely to be caused by the event the following regulation shall be observed:-

THAT, except as provided by the order, use, by all vehicular traffic, including pedal cycles but with the exception of Emergency Services Vehicles, of the said streets or parts thereof shall be restricted between the hours specified in column 3 of the said schedule. The penalty for infringement of the said regulation is a fine not exceeding £1000.00.
