(PUBLIC FOOTPATH N° 1 ST ANDREWS MINOR)
PUBLIC PATH DIVERSION ORDER 2024

The above Order, made on the 31st January 2024, under Section 119 of the Highways Act 1980, will divert the public footpath at Clemenstone running from a point on the lane at NGR 292352 173655 and proceeding northwards to the east side of Tynewydd Farm before turning westwards to a stone stile at NGR 292364 173741, to a point on the lane at NGR 292352 173655 and proceeding westwards along the lane to the entrance to Tynewydd Farm at NGR 292404 173697, then northwards along the property's drive to a stone stile at NGR 292364 173741 as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at The Civic Offices, Holton Road, Barry, Vale of Glamorgan CF63 4RU. Copies of the Order and map may be bought at the price of £4.50.

Any representations about or objections to the Order may be sent in writing to the Head of Regeneration and Planning, The Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT not later than the 4th April 2024. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
