PUBLIC PATH EXTINGUISHMENT ORDER 2023**

On the 18<sup>th</sup> January 2024 the Vale of Glamorgan Council confirmed the above Order made under section 118 of the Highways Act 1980.

The effect of the Order as confirmed is to extinguish the public footpath running from NGR 294011 167904 to NGR 294008 167886 at St Donats and the public footpath running from NGR 294008 167886 to NGR 294564 167772 as set out in the Schedule and shown in the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at the Civic Offices, Holton Road, Barry, Vale of Glamorgan CF63 4RU. Copies of the Order and map may be bought there at a price of £4.50.

This Order comes into force on 18<sup>th</sup> January 2024, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 8<sup>th</sup> February 2024 make an application to the High Court.

This Order is made by the Vale of Glamorgan Council ("the Authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that the footpath described below is not needed for public use.

#### BY THIS ORDER

1. The public rights of way over the land situate at St Donats NGR 294677 167847 and shown by a bold continuous line on the map attached to this Order and described in the Schedule to this Order shall be extinguished after 28 days from the date of confirmation of this Order.

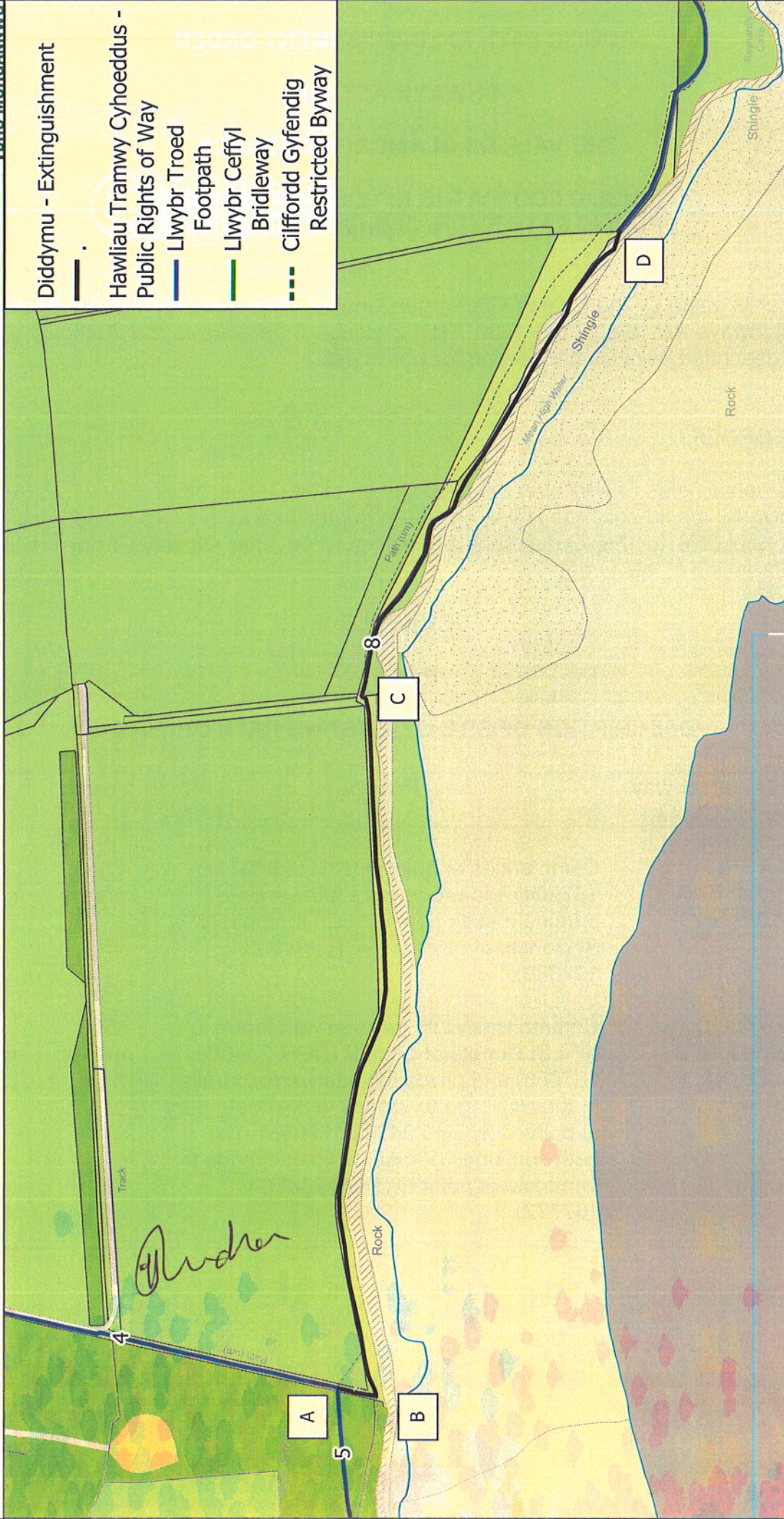

<b>A – B</b> Footpath N <sup>o</sup> 4 St Donats	Commences at point A (NGR 294011 167904) and proceeds southwards to terminate at its junction with footpath N <sup>o</sup> .8 St Donats at point B (NGR 294008 167886).	18 metres	0.3 metres
<b>B – C – D</b> Footpath N <sup>o</sup> 8 St Donats	Commences at its junction with footpath N <sup>o</sup> 4 St Donats at point B (NGR 294008 167886) and proceeds eastwards parallel to the cliff edge to cross the field boundary at point C (NGR 294342 167893). The path continues parallel to the cliff edge to terminate at point D (NGR 294564 167772).	599 metres	0.6 metres
