Effaith y Gorchymyn fel y'i cadarnhawyd yw creu llwybr cyhoeddus o dir i'r dwyrain o Goleg Byd Unedig yr Iwerydd, Sain Dunwyd CGC 294011 167904 tua'r dwyrain yn gyfochrog â'r arfordir hyd at CDC 294562 167799 fel y nodir yn yr Atodlen ac a ddangosir ym map y Gorchymyn.

PUBLIC PATH CREATION ORDER 2023**

On the 18<sup>th</sup> January 2024 the Vale of Glamorgan Council confirmed the above Order made under section 26 of the Highways Act 1980.

The effect of the Order as confirmed is to create a public footpath from land to the east of United World College of the Atlantic, St Donats NGR 294011 167904 eastwards parallel to the coastline to NGR 294562 167799 as set out in the Schedule and shown in the Order map.

A copy of the Order as confirmed and the Order map may be seen free of charge at the Civic Offices, Holton Road, Barry, Vale of Glamorgan CF63 4RU during normal office hours. Copies of the Order and map may be bought there at a price of £4.50.

This Order comes into force on 18<sup>th</sup> January 2024, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 8<sup>th</sup> February 2024 make an application to the High Court.

**PUBLIC PATH CREATION ORDER 2023**

This Order is made by the Vale of Glamorgan Council ("the Authority") under Section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that, having regard to the matters set out in Section 26(1), there is a need for a public footpath over the land to which this Order relates, and that it is expedient that the path should be created.

**BY THIS ORDER**

1. A public footpath over the land situate at St. Donats, shown by a bold broken line on the map contained in this Order and described in Part 1 of the Schedule to this Order, shall be created after 28 days from the date of confirmation of this Order.
2. Notwithstanding this Order any statutory undertaker having apparatus in, on, over, along or across the land referred to in paragraph 1 for the purpose of carrying on their undertaking shall have the same rights in respect of the apparatus as they had immediately before the date on which the footpath was created.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 2 of the Schedule.

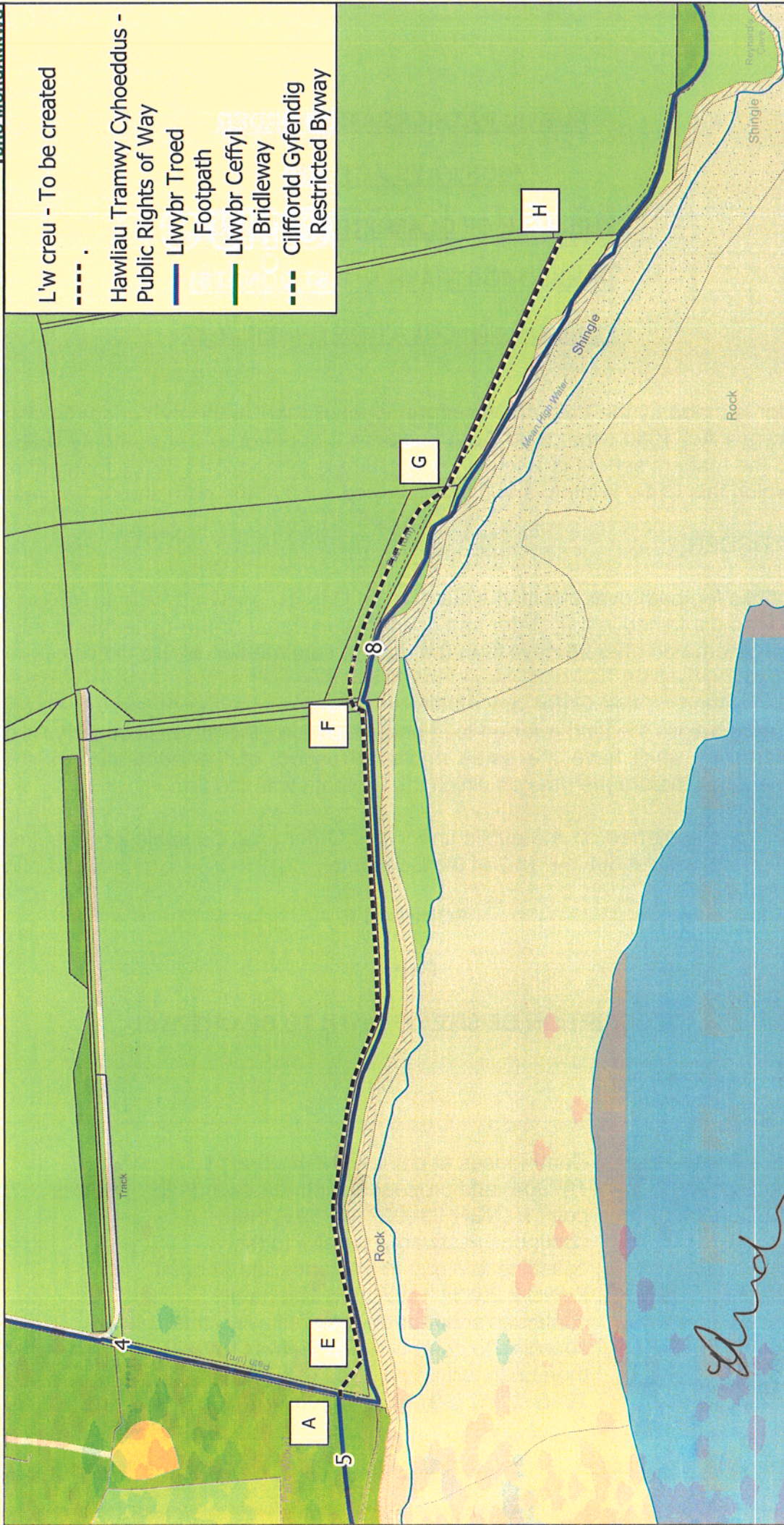

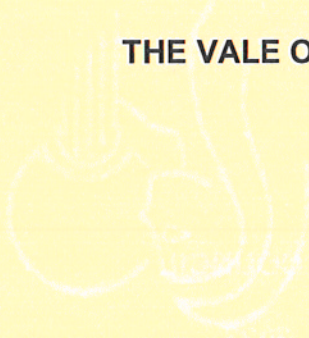
