Open Register – Opt Out Request

**We recently received a Household Enquiry Form from you or a member of your household confirming the residents at your address. The Household Enquiry Form indicated you wish to opt out of the Open Register.**

**Under data protection legislation any request has to come from you, not through a third party or other member of the household, and we cannot process these requests via a Household Enquiry Form. Therefore if you do wish to opt-out of the Open Register, please complete and return the enclosed form or contact us via email or telephone.**

The open register

There are two registers. Why?

Using information received from the public, registration officers keep two registers – the electoral register and the open register (also known as the edited register).

#### **The electoral register**

The electoral register lists the names and addresses of everyone who is registered to vote in public elections. The register is used for electoral purposes, such as making sure only eligible people can vote. It is also used for other limited purposes specified in law, such as:

- detecting crime (e.g. fraud)
- calling people for jury service
- checking credit applications

#### **The open register**

The open register is an extract of the electoral register, but is not used for elections. It can be bought by any person, company or organisation. For example, it is used by businesses and charities to confirm name and address details.

Your name and address will be included in the open register unless you ask for them to be removed. Removing your details from the open register does not affect your right to vote. #### **Your personal information**

We will only use the information you give us for electoral purposes. We will look after personal information securely and we will follow the Data Protection Act 1998. We will not give personal information about you and the other people in your household to anyone else or another organisation unless we have to by law.
