

**THE VALE OF GLAMORGAN COUNCIL  
(EGLWYS BREWYS PUBLIC FOOTPATH No 1)  
(TEMPORARY CLOSURE) ORDER 2020**

On the 1<sup>st</sup> October 2020 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984, made an Order as described in the schedules below:

The Order shall come into force on 1<sup>st</sup> October 2020 and will be known as "The Vale of Glamorgan Council Eglwys Brewys Public Footpath No 1 (Temporary Closure) Order 2020.

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 1<sup>st</sup> October 2020 apply to the High Court for this purpose

1. No person shall proceed on foot in the locations specified in Schedule 2 below.

**SCHEDULE 2**

<b><u>Location</u></b>	Footpath (Public Rights of Way) known as Eglwys Brewys Number 1 closed from the point it meets the Cowbridge Road
<b><u>Alt. Route</u></b>	During this closure a signed diversion via Flemingston Road will be available
<b><u>Reason</u></b>	To prevent danger to the Public as a result of highway construction works being carried out.
<b><u>Duration</u></b>	From 8am on 1 <sup>st</sup> October 2020 for a maximum period of six months Dated this 1 <sup>st</sup> day of October 2020 Director of Environment & Housing Vale of Glamorgan Council, The Alps Depot, Wenvoe. CF5 6AA.
