**PUBLIC PATH DIVERSION ORDER 2020**

The above Order was made on 22<sup>nd</sup> October 2020. The effect of the Order will be to divert the public footpath running from the Cowbridge / St Athan road NGR 301132 169360 north-eastwards crossing a field to NGR 301202 069552 and create an alternative footpath to a line running from Cowbridge / St Athan road NGR 301226 169332 northwards parallel to the field boundary to NGR 301202 169552 as shown on the Order map.

Any representation about or objection to the Order may be sent or delivered in writing addressed to the Head of Regeneration and Planning, The Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT not later than the 17<sup>th</sup> December 2020. Please state the grounds on which it is made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may itself confirm the Order as an unopposed Order. If the Order is sent to the Welsh Ministers for confirmation any representations or objections which have not been withdrawn will be sent with the Order.
