**THE VALE OF GLAMORGAN COUNCIL
(LLANBLETHIAN PUBLIC FOOTPATH No 50 & 51)
(TEMPORARY CLOSURE) ORDER 2020**

On the 10th September 2020 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order as described in the schedules below:

The Order shall come into force on 12th September 2020 and will be known as "The Vale of Glamorgan Council Llanblethian Public Footpath No 50 & 51 (Temporary Closure) Order 2020.

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 12th September 2020 apply to the High Court for this purpose

SCHEDULE 1

No person shall proceed on foot in the locations specified in Schedule 2 below.

SCHEDULE 2

Location 1 Footpath (Public Rights of Way) known as Llanblethian Number 50 closed from the point at grid ref 297992,174593 in an easterly direction to grid reference 298274,174752 for a distance of 330 metres

Alt. Route During this closure a diversion via the A48 and the remaining open section of footpath will be available.

Location 2

Footpath (Public Rights of Way) known as Llanblethian Number 51 closed from the point from where this path meets the Llantwit Major Road, Cowbridge at grid 298419 174557, and continuing in a north westerly direction to where this footway meets the Public Right of Way known as Llanblethian No 50, at grid 298248 174735.

Alt. Route

During this closure there will be no diversion

Reason

To prevent danger to the Public as a result of construction works being carried out.

Duration

From 00.01 on Saturday 12th September 2020 for a maximum period of six Months
