**THE VALE OF GLAMORGAN COUNCIL
(BARRY PUBLIC FOOTPATH Nos 30, 31 & 32)
PORTHKERRY PARK (TEMPORARY CLOSURE) ORDER 2021**

On the 21st January 2021 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order as described in the schedules below:

The Order shall come into force on 21st January 2021 and will be known as "The Vale of Glamorgan Council (Barry Public Footpath Nos 30, 31 & 32) (Temporary Closure) Order 2021.

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 21st January 2021 apply to the High Court for this purpose

SCHEDULE 1

No person shall proceed on foot in the locations specified in Schedule 2 below.

SCHEDULE 2

Location Footpath (Public Rights of Way) known as Barry Numbers 30, 31 & 32 closed throughout their lengths

Alt. Route During this closure there will be signed diversions via Salisbury Road, Oxford Street & Fishponds Hill

Reason To prevent danger to pedestrians while resurfacing work is carried out.

Duration From 00.01 on Thursday 21st January 2021 for a maximum period of six months or until works are completed whichever is the earlier.
