HIGHWAYS ACT 1980

(PUBLIC FOOTPATH N° 13 ST ANDREW'S MAJOR)
PUBLIC PATH DIVERSION ORDER 2021

The above Order, made on the 15th March 2021, under Section 119 of the Highways Act 1980, will divert the public footpath running from a point on the driveway to Southra Farm NGR 314928 170796 proceeding southwards across land to the west of the farmhouse before turning westwards to terminate at NGR 314793 170711, to a line running from a point on the driveway to Southra Farm NGR 314928 170796 proceeding westwards then southwards across an open field to terminate at NGR 314793 170711 as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at the Civic Offices, Holton Road, Barry, Vale of Glamorgan CF63 4RU. Copies of the Order and map may be bought at the price of £4.50.

Any representations about or objections to the Order may be sent in writing to the Head of Regeneration and Planning, The Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT not later than the 20th May 2021. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
