PUBLIC PATH DIVERSION ORDER 2021

The above Order, made on the 15th March 2021, under Section 119 of the Highways Act 1980, will divert the public footpath running from a point to the west of Ty Candy Farm, Treoes NGR 294858 179143 proceeding north-north-westwards to terminate to the south-east of a footbridge over the Ewenny River NGR 294798 179298 to a line running from the point to the west of Ty Candy Farm, Treoes NGR 294731 179134 north-north-eastwards to terminate to the south-east of a footbridge over the Ewenny River NGR 294798 179298 as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at the Civic Offices, Holton Road, Barry, Vale of Glamorgan CF63 4RU during normal office hours. Copies of the Order and map may be bought there at the price of £4.50.

Any representations about or objections to the Order may be sent in writing to the Head of Regeneration and Planning, The Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT not later than the 27th May 2021. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
