# Proposed Prohibition Waiting and Loading At Any Time Stanwell Road

On the northwest side from the junction with Dyserth Road in a south westerly direction for a distance of 24 metres.

On the southeast side from the junction with Archer Road in a south westerly direction for a distance of 24 metres.

On the southeast side from a point 43 metres southwest of the junction with Archer Road, in a south westerly direction for a distance of 9 metres.

#### **Dyserth Road**

On the both sides from the junction with Stanwell Road in a north westerly direction for a distance of 15 metres.

#### SCHEDULE 2

### Proposed Prohibition Loading At Any Time Stanwell Road

On the north west side from the junction with Dyserth Road in a north easterly direction for a distance of 55 metres.

On the southeast side from the junction with Archer Road in a north easterly direction for a distance of 12 metres.

#### Archer Road

On both sides from the junction with Stanwell Road in a south easterly direction for a distance of 18 metres.
