(CIVIL ENFORCEMENT) (AMENDMENT) (NO 9) ORDER 2022

- On the 21st February 2023 The Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and all other enabling powers made an Order to install and amend the parking restrictions specified in the schedule below.
- 2. The Order will come into operation on 26th February 2023 or on the dates that the signs and road markings are installed whichever is the later and shall be known as the "Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 9) Order 2022"
- 3. A copy of the Order and plans showing the affected area may be inspected on the Council's website at www.valeofglamorgan.gov.uk
- 4. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 26th February 2023 apply to the High Court for this purpose.

The following Traffic Regulation Order is to be amended as follows:

Prohibition of Waiting and Loading, and Unloading At Any Time Rhoose Way Rhoose

On the western side, from the southern junction with Greenmeadow Way in a northerly direction for a distance of 17.1m.

On the southern side, from a point 58.5m west of its junction with the north-western corner of the exit from the school car park in a westerly direction for a distance of 21.5m.

On the southwestern side, from its junction with the southeastern corner of the entrance into to the school car park in a south-easterly then in a general north westerly direction for a distance of 79.3m.

On the eastern side from a point 20.8m south of the junction with Greenmeadow Way in a southerly and then easterly direction for a distance of 39.2m.

Greenmeadow Way

On the north-western side, from its junction with Rhoose Way in a south-westerly direction for a distance of 12.2m.

On the south-eastern side, from its junction with Rhoose Way in a south-westerly direction for a distance of f 13.2m.

Prohibition of Waiting, Loading and Unloading Monday to Friday 8am to 9:30am and 2:30pm to 4pm

On the eastern side, from its junction with Greenmeadow Way in a southernly direction for a distance of 20.8m

On the north-eastern side, from a point 2m northwest of front face wall of property no. 263-271 in a general north-westerly then westerly direction for a distance of 93.2m. On the south-western side, from its junction with the north-western corner of the entrance to the school car park in a north-westerly direction for a distance of 41.4m.

On the southern side, from a point 43.9m west of its junction with the north-western corner of the exit from the school car park in a westerly direction for a distance of 14.9m.
