Proposed Prohibition of Waiting, Loading and Unloading At Any Time

#### Ffordd y Mileniwm

On the south east side, from the junction with the south western side of Neptune Road in a south westerly direction for a distance of approximately 158m.

On the north west side, from the junction with the north eastern side for Stryd Sant Baruc in a north easterly direction for a distance of approximately 78m.

On the north west side, from the junction with the south western side of Stryd Sant Baruc in a south westerly direction for a distance of approximately 51m.

### **Neptune Road**

On the north east side, from the junction with the south eastern side of Ffordd y Mileniwm, in a south easterly direction for a distance of approximately 72m.

On the south west side, from the junction with the south eastern side of Ffordd y Mileniwm, in a south easterly direction for a distance of approximately 54m.

On the south west side, from a point approximately 62m south east of the junction with the south eastern side of Ffordd y Mileniwm, in a south easterly direction for a distance of approximately 25m.

## **Stryd Sant Baruc**

On the north east side, from the junction with the north western side of Ffordd y Mileniwm, in a northerly direction for a distance of approximately 60m

On the south western side from the junction with the north western side of Ffordd y Mileniwm in a north westerly direction for a distance of approximately 40m.

On the south-western side, from a point approximately 50m north west of the junction with the north western side of Ffordd y Mileniwm, in a north-westerly direction for a distance of approximately 20m.

## **Unnamed Road leading to Ysgol Gymraeg Sant Baruc**

On both sides from the junction with the south western side of Stryd Sant Baruc, in a south westerly direction for a distance of approximately 15m.
