Report Title:	Contract for the Provision of Childcare for Flying Start in Dinas Powys, Vale of Glamorgan.
Purpose of Report:	To seek authority to undertake a tender process relating to the provision of childcare for the Vale of Glamorgan Flying Start Programme within the new setting in the grounds of Dinas Powys Primary School. To seek delegated authority to award the contract to the successful provider.

Executive Summary:

- The purpose of this report is to seek authority to undertake a tender process relating to the provision of childcare for the Vale of Glamorgan Flying Start Programme within the new setting in the grounds of Dinas Powys Primary School and enter into a contract with the successful provider.
- The contract is to be awarded for two years initially, with an option to extend for up to a further two years in negotiation with the successful providers subject to the ongoing award of the Flying Start grant by Welsh Government.
- The contract is envisaged to commence in Autumn 2024, subject to the successful provider's completion of Care Inspectorate Wales (CIW) registration requirements.

Recommendations

- 1. That Cabinet authorises the Director of Social Services, in consultation with the Cabinet Member for Social Care & Health to undertake a competitive tender process for the provision of Flying Start services in Dinas Powys.
- 2. That Cabinet authorises the Director of Social Services, in consultation with the Cabinet Member for Social Care & Health to award the contract(s) for this service for an initial period of two years with an option to extend for up to a further two years, following the completion of the tender process.
- **3.** That Cabinet grant delegated authority to the Monitoring Officer/Head of Legal and Democratic Services to prepare, complete and execute a contract with the successful bidder.

Reasons for Recommendations

- 1. To enable the Directorate to undertake a tender process that will provide Flying Start childcare within Dinas Powys in a cost-effective way that meets the requirements of Welsh Government Flying Start Guidance and the required standards of the Care Inspectorate Wales (CIW).
- 2. To ensure that the service is in place for the next two years with the potential to extend it for a further two years if required.
- **3.** To ensure that the appropriate authority and documentation are in placement to complete the contract.

1. Background

- 1.1 The Flying Start programme in the Vale of Glamorgan is a Welsh Government initiative, providing families with children aged 0-3 years with a range of intensive prevention services.
- 1.2 The provision of high-quality childcare for children from 2-3 years of age is the centrepiece of the service delivered under the Flying Start initiative. The quality childcare provision focuses on children living in disadvantaged communities and aims to improve their outcomes in preparation for school and in the long term.
- 1.3 The childcare unit at Dinas Powys Junior School site is a joint project which will deliver, whilst within separate rooms, education, and childcare from a new demountable building. This unit will support those children within the expansion area for Flying Start and / or eligible for the 2-year-old offer. There will be an opportunity for up to 16 places for children aged 3+ not eligible for the Childcare Offer.
- 1.4 The provision of high quality, part-time childcare for 2–3-year-olds is integral to the Flying Start programme. Quality childcare contributes to the acquisition of skills and abilities, socialisation, and the ability to play and concentrate. These are crucial, not only to a child's subsequent ability to learn, but also to participate effectively in a group environment. Research suggests that quality

Early Childhood Education and Care (ECEC) leads to improvements in children's development in later years, such as enhanced language skills; better educational performance in mathematics and reading; and an increase in positive behaviour/outcomes.

- **1.5** Flying Start is based on the following expectations:
 - Staff working with young children should be suitably trained and qualified, understand how children develop and learn and be sensitive and responsive to their needs and feelings.
 - o The role of the adult within the setting is to support and enrich children's learning, rather than to direct it.
 - o Children need a caring, stimulating environment.

2. Key Issues for Consideration

- 2.1 The tender process will be managed by a project group which includes representatives from Flying Start, Procurement and Commissioning teams. The group has been meeting frequently to allow timely discussions to be held with regards to issues that may occur within the tender process. Informed debate and discussion will be allowed for decisions to be agreed, ensuring continued progress of the tender process within required timescales.
- **2.2** Following advertising of the tender process, organisations will complete an Invitation to Tender (ITT).
- 2.3 The quality element of the submission will be evaluated through several means and will cover areas that have been weighted appropriately in accordance with importance.
- 2.4 All bidders will be asked to provide written submissions against quality questions included within the ITT document. Their written submissions will be assessed by an internal evaluation panel.
- 2.5 Providers will also be evaluated on their quality through an interview process. Bidders are to be asked to present their proposals and answer a series of formal questions to the evaluation panel. These responses will be evaluated and scored by the panel.
- 2.6 Parents will also be involved in the quality element of the process, with them asking direct questions of the potential providers during the interview stage.
- Following the evaluation of overall quality, this will be combined with the bidder's due diligence responses within their Pre-Qualification Questionnaire (PQQ) to identify the preferred provider for the service.
- 2.8 The contract is to be awarded initially for two (2) years with an option to extend for up to a further two (2) years in negotiation with the successful bidder.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

- 3.1 The Well-being of Future Generations Act 2015 ("the 2015 Act") requires the Council to think about the long-term impact of their decisions, to work better with people, communities, and each other and to prevent persistent problems such as poverty, health inequalities and climate change.
- 3.2 To make sure we are all working towards the same purpose, the 2015 Act places seven well-being goals on the Council. The 2015 Act makes it clear the listed public bodies must work to achieve all the goals, not just one or two, these being:
 - A Prosperous Wales
 - A resilient Wales
 - A healthier Wales
 - A more equal Wales
 - A Wales of cohesive communities
 - A Wales of vibrant culture and Welsh language
 - A globally responsible Wales
- 3.3 By embedding the five ways of working, the Council is working in a more sustainable way. The Council aims to meet these as detailed below:

Long Term

- 3.4 The Council's commitment to providing the service within the Flying Start Childcare scheme represents a focus on the long-term wellbeing of children, by promoting and fostering a culture of independence.
- 3.5 The delivery of the Flying Start Scheme aims to support the Welsh Government's commitment to provide high quality childcare, which supports children's development and school readiness as well as enabling more parents to access education or training or who are on the edge of work.

Taking an Integrated Approach

- 3.6 The Council expects that the successful bidder will build upon existing relationships with other professionals and agencies to avoid duplication and to maximise positive outcomes.
- 3.7 There is an opportunity for teams across the Council to work closely and in an integrated manner to achieve the delivery of Welsh Government's commitment to expand Flying Start provision in the Vale of Glamorgan.

Involving People

3.8 Each parent using the service is supported to participate in decisions affecting their children and be involved in planning, reviewing, and designing services. This ensures they are safe; have a say; experience new activities and feel involved, secure, and confident in the service provided to them.

3.9 Involvement of parents will also be central to the commissioning process, whereby a parents' panel will ask questions to bidding organisations at the interview stage of the procurement process. The scores of these questions will be given equal weighting to those posed by the Commissioners' interview panel.

Collaborating with Others

3.10 Service provision is not effective without collaboration with the parents using the service, but also partner organisations. The Flying Start scheme has and will continue to involve collaboration with internal officers across Directorates of the Council, third sector organisations and the successful childcare provider.

<u>Prevention</u>

3.11 The aim of Flying Start is to improve outcomes for children in the most deprived communities across Wales. Targeted investment is used to offer free, part-time, high-quality childcare for two- to three-year-olds; enhanced health visitor support; parenting programmes; and early language development, thus aiming to reduce the demand for additional services. There is evidence to show a good start in life leads to better outcomes in later life.

4. Climate Change and Nature Implications

- 4.1 In December 2020, the Climate Change Committee published its progress report "Reducing Carbon Emissions in Wales". This is the first report on Wales's progress towards meeting its emission reduction targets, as required under Article 45 of the Environment (Wales) Act 2016.
- **4.2** Providing a local service will encourage those who use the facility to commute via active travel. The facility will engage with staff, parents, and care givers to use alternative modes of transport to reduce the environmental impact of the new service.

5. Resources and Legal Considerations

Financial

- 5.1 In October 2023, The Vale of Glamorgan Early Years/Flying Start team were awarded £550,000 Capital funding, via the Welsh Government's Childcare and Early Years Capital Grant Programme 2023-2025. The funding was awarded to establish a new childcare provision on the Dinas Powys Junior School site. The funding was added to the already awarded Section 106 Capital funding, which was supporting replacing two classrooms within a modular building which has been completed and the official key hand over is on 3 June 2024.
- 5.2 It is the intention of the Vale of Glamorgan to undertake a procurement exercise to identify a suitable provider for the service set out above.
- 5.3 Services for Vale of Glamorgan service users will be funded by the Welsh Government to support the expansion of Flying Start Childcare. It is envisaged that the total annual cost of the service provision will be in the region of £43,680,

based on 16 spaces, paid from Social Services Flying Start budget. The successful provider will have the opportunity to offer spaces to up to 14 private clients per session in addition to the above number.

Employment

5.4 The process of monitoring the service will be undertaken by staff within the Social Services Directorate, making appropriate use of corporate expertise and processes in areas such as procurement, finance and HR where required.

Legal (Including Equalities)

- **5.5** This will be a new contract, therefore, TUPE and considerations will not apply.
- 5.6 The review of all working arrangements between the Council and other agencies will ensure that services are provided through robust contracts that fully reflect the responsibilities of the Council and the provider.
