# C193 CONSULTATION ON THE DRAFT SCHOOL ACCESSIBILITY STRATEGY 2025-2027 (REF) –

The reference from Learning and Culture Scrutiny Committee held on 4th November, 2024 was presented.

The Cabinet Member said there was an interesting discussion with a variety of questions raised by the Committee, mostly regarding matters concerning Additional Learning Needs. Committee made the following Recommendations to Cabinet as part of the proposed consultation exercise which Cabinet agreed were:-

- The importance of assessing and considering the needs of the children that were not in education and not homeschooled and how the Council accounted for them as part of the Strategy, including any additional learning needs they may have.
- The positive benefits of building the second Ysgol Y Deri school through providing extra capacity for additional learning needs.
- The importance of continued provision of comprehensive and agile specialist outreach services that support children with learning difficulties across mainstream schools in the Vale of Glamorgan, to the same high standard.

# C194 6 MONTH UPDATE REPORT ON LOCAL BUS SERVICES IN THE VALE OF GLAMORGAN (REF) –

The reference from Environment and Regeneration Scrutiny Committee held on 12<sup>th</sup> November, 2024 was presented.

The Deputy Leader said that the Committee had received a presentation at the meeting and updates on matters including contract awards and funding, accessibility of bus timetables, regional partnership working and connectivity.

A strong and robust discussion took place at the Committee meeting with a number of questions asked and points raised with local Members having an opportunity to discuss issues within their own wards and concerns of residents that had been raised with them directly.

There was concern about the provision of local school bus and transport services and a specific query raised regarding pupils who did not qualify for free school transport from Barry Island to Whitmore School. The Authority was close to a £1.2m overspend on school transport which meant a need to concentrate on statutory duty or providing free school transport for those who met qualifying criteria.

Committee also expressed concern about the discussions that were happening around passenger numbers between bus service providers and Welsh Government which were not being shared with the Council. Committee asked that Cabinet used its discussions at various levels of Welsh Government in order to highlight greater data sharing and the other comments/issues raised which was acknowledged and would be progressed at Welsh Government and Regional Transport Authority level.

A further report would be provided to Committee on 10th December 2024 regarding the reintroduction of the Greenlinks G1 service.

Councillor John thanked the Cabinet and in particular the Deputy Leader for supporting bus services in the Western Vale. The Deputy Leader thanked the Officers concerned who kept up to date with changes to services as they happened and worked to support services across the Vale of Glamorgan.

The Leader said that the Authority continued to work with Transport for Wales and UK Government to increase capacity on lines going forward.

## C196 SCHOOL ADMISSIONS ARRANGEMENTS 2026/2027 (EAWL) (SCRUTINY – LEARNING AND CULTURE) –
