### **Executive Summary:**

To obtain Council's approval to:

- Include an additional delegation for all Directors or Service Heads for Authority to accept and enter into contracts for the sale of goods and materials to the value of £300,000 as referred to in paragraph 2.2 of this report.
- Include an additional delegation under the delegations of the Head of Democratic Services as referred to in paragraph 2.3 of this report.
- Include an additional delegation under the delegations of Director of Environment and Housing and Head of Shared Regulatory Services as referred to in paragraph 2.4 of this report.

#### Recommendation

1. THAT the changes to the relevant officer delegations as set out in paragraphs 2.2 to 2.4 of this report be approved and that Section 26 of the Constitution be amended accordingly.

### **Reason for Recommendation**

1. To update the Officer Delegation Scheme within the current Constitution.

### 1. Background

- 1.1 The Constitution remains under review on an ongoing basis. Under Section 2.4 of the Constitution the Monitoring Officer / Head of Legal and Democratic Services has a duty to monitor and review the operation of the Constitution to ensure that the aims and principles contained therein are given full effect. As part of this, a key role is to make recommendations to Council for ways the Constitution could be amended so that current democratic processes operate effectively and efficiently being mindful of arrangements in other comparable Local Authorities.
- 1.2 Having a Constitution which is reviewed and updated regularly serves a valuable and relevant purpose by striking a fair balance between the interests of the various groups within the Council e.g. between the largest political group and opposition group, between all Councillors and between Councillors and officers.
- 1.3 Most importantly the Constitution needs to enable the Council to operate effectively. It must deliver:
  - good governance behaviours
  - effective officer / Member relationships
  - clear and effective decision-making
  - strong accountability
  - clarity and consistency.

# 2. Key Issues for Consideration

2.1 The Monitoring Officer / Head of Legal and Democratic Services has considered various aspects of the Constitution and in the interests of good governance, consistency and public participation recommends to Full Council amendments to some aspects of Section 26 – Officer Delegations as below.

### 2.2 Officer Delegations – All Directors or Service Heads

Currently any requests by political Group Leaders for Membership Changes on Council Committees during the Municipal year are referred to the Chief Executive for consideration under his Emergency Powers. It is therefore suggested to limit the use of the Chief Executive's Emergency Powers that a delegation be granted to the Head of Democratic Services to make amendments to memberships of Council Committees following the receipt of a request in writing by a Group Leader of the respective political party.
