Constituency Activity and Achievements

As a County Councillor, I continue to play a major role inside and outside the Council Chamber.

This includes drawing attention to the £2.7m expenditure on a bus station at Barry Docks which continues to receive limited service and use, and the Council's published over-spend of £3.7m on their new Oracle Fusion, whose 'Lessons Learnt' report was brought to committee following my earlier request.

I support local residents in reporting fly-tipping and potholes, providing advice, and support around housing and planning queries. I often work with partners inside and outside the council, for example arranging a multi-agency joint meeting with residents, leisure, highways and Police to resolve parking issues near Jenner Park Stadium; touring the area with residents to understand mobility challenges, leading to improvements in accessible travel along Gladstone Road, and working with council officers to resolve issues around a dangerous building in Regent Street.

As a town centre councillor, I am always concerned that Holton Road receives appropriate funding and support to prevent anti-social behaviour in the area and that businesses are given assistance required.

I voted against the 6.7% increase in council tax in this year's Budget and the same increase in council house rents, recognising the impact that this level of increase has upon residents and tenants.

I have spoken frequently in Council, bringing forward motions about Bus Services in the Vale, and amending the process for an electronic vote in Council to increase transparency. I contribute to the Council's Corporate Performance and Resources Committee and Planning meetings, where I voted against plans to turn Crossway Methodist Church into housing because of the size of the proposed units, and against the Barry Docks Incinerator proposals.

I requested that the proposals for sports facilities at the Colcot and Buttrills Fields were discussed by the Healthy Living and Social Care Committee, and that Homes & Safe Communities committee scrutinised the Safe Vale Partnership's Five-Year Plan.

As a council trustee at the Alexandra Gardens Community Association, I have supported them with their Strong Communities Fund application to make the building carbon neutral.

I am a member of the Council's Task & Finish Group on improved procurement practices and have also worked closely with the newly-appointed Senior Community Development Officer, meeting frequently to consider how we can best tackle poverty in the area.

In Full Council, I have raised questions on the following matters:

- The number of subscriptions to the new Paid Gardening Waste Service
- Fly-tipping Incidents in the Vale of Glamorgan
- The number of schools in the Vale of Glamorgan setting 'deficit budgets', meaning

that they anticipated a loss during the current financial year

- How the Vale Council would make up for Welsh Government's failure to provide Free School Meals during the school Summer Holidays
- The number of proposed services at the Barry Docks Transport Interchange, which I had previously raised in 2022-23
- The introduction of the 20mph speed limit in September 2023
- Predicted carbon emissions from the Barry Docks Incinerator
- The Planning Framework and decision-making process for the Incinerator
- Progress towards the Vale of Glamorgan becoming a County of Sanctuary
- Promotion of Arts and Culture in the Vale of Glamorgan
