The Capital Programme for 2020/2021 was agreed by Council on 26th February 2020 and included several new schemes, particularly in schools, to be completed in the new financial year. Since the start of the Covid19 epidemic, the Council has experienced issues with contractors pulling off site, either because they cannot adhere to the social isolating requirements, they are experiencing a reduction in staff numbers or they are unable to access supplies as those outlets have now closed.

Following advice from legal services, it has been agreed that where a contract is non-essential and cannot be performed before the end of the crisis that we should not be entering into it. Therefore it has been agreed that all non essential schemes should be delayed until such time as contractors would be able to meet the full obligations of contracts entered into.
