Due to Government guidance on Social distancing and travel restrictions, the service is experiencing a significant reduction in demand for service and only emergency repairs are being received. Additionally, in an attempt to reduce exposure and keep members of staff safe, a rota has been introduced which enables all emergency works to be attended whilst keeping other staff members away from continued exposure.

Members of the repair staff have been permitted to take their vehicles home to enable a home start for the workforce and therefore further reduce staff gatherings and unnecessary travel.
