#### It was resolved:

- T H A T the Advertising and Sponsorship Protocol contained in Appendix A attached to the report be approved.
- T H A T subject to resolution two above, delegated authority be granted to the relevant Head of Service in consultation with the Leader, Managing Director and Section 151 Officer to promote and agree sponsorship and advertising opportunities and award necessary contracts in line with the Advertising and Sponsorship Protocol contained in Appendix A attached to the report. Where it was deemed appropriate to do so, further reports to Cabinet on specific opportunities would be reported.

Since the protocol was approved in April 2018, a number of changes have taken place regarding the Council's Advertising and Sponsorship activity and as such, slight variations to the protocol would be beneficial.

The main change required would complement the new processes put in place since the Council have brought Roundabout Advertising back in house after terminating its contract with Immediate Solutions. In the recent fees and charges report to Cabinet

Environment and Housing to vary fee levels in appropriate circumstances in respect of roundabout advertising contracts.

This Emergency Powers form requests two changes as follows.

## Change 1

The Advertising and Sponsorship Protocol linked to above states in section 7.4 that "All Advertising and Sponsorship Agreements must be referred to Legal & Financial Services for review prior to agreement where the value exceeds £1,000".

It is proposed this wording is amended to increase this limit to £5,000 which would enable the fees and charges in respect of Roundabout Advertising to be implemented in line with the protocol without referral to Legal Services in each case an arrangement is entered in to.

It is proposed a standard legal agreement will be put in place (as in the case for filming arrangements) with reference to the Advertising and Sponsorship protocol to enable agreements to be put in place without Legal input every time, making the process smoother and without taking up valuable Legal Services time.

## Change 2

Under section 4.4. 'Vaping/Smoking' is added to the list of prohibited adverts
