On 15<sup>th</sup> May emergency powers were signed to reverse the previously agreed temporary closure of a number of footpaths at Atlantic College, Cosmeston, Dunraven Bay, Ogmore by Sea, and Porthkerry.

The routes were to be reopened to allow members of the public to exercise only and all signage regarding the closures and references on the Council's Web site were to be removed by Saturday 16th May 2020.

Public Footpath 73, Barry which provides access to Porthkerry Park was however unable to be opened by Vale Staff and remained obstructed by the affected landowner. The landowners were contacted by the Council advising that enforcement would be considered and it was represented by them, in response, that specific health vulnerabilities existed to justify continued closure.

The landowners representations have been considered in the light of advice from the Council's legal department and it is now recommended that closure of the path be reinstated. This should be subject to periodic review that we propose will be undertaken in line the release of updated advice for people that are shielding, the next revision of which is expected 16<sup>th</sup> June.
