91 STANDARDS COMMITTEE MEETING WITH GROUP LEADERS IN COMPLIANCE WITH THE STATUTORY AND NON-STATUTORY GUIDANCE FOR PRINCIPAL COUNCILS IN WALES. SUPPORTING PROVISIONS WITHIN THE LOCAL GOVERNMENT ACT 2000, THE LOCAL GOVERNMENT (WALES) MEASURE 2011 AND THE LOCAL GOVERNMENT AND ELECTIONS (WALES) ACT 2021 ISSUED JUNE 2023 (MO/HLDS) –

The report was presented by the Monitoring Officer / Head of Legal and Democratic Services, the purpose of which was to provide the Committee with an update following the publication of Welsh Government Statutory and Non–Statutory Guidance.

Having regard to the Local Government and Elections (Wales) Act 2021 Welsh Government provided Interim Guidance on the provisions and duties of the aspects relating to the Standards Committee in May 2022.

In June 2023 Welsh Government published updated Statutory and Non-Statutory Guidance for Principal Councils in Wales – supporting provisions within the Local Government Act 2000, the Local Government (Wales) Measure 2011 and the Local Government and Elections (Wales) Act 2021.

The above Guidance covered a number of aspects however the matters specific to the remit of the Standards Committee could be found at sections 4.0, 5.0, 6.0 and 7.0 of Part 2 of the Guidance.

The Monitoring Officer / Head of Legal and Democratic advised that the Guidance advised that at the beginning of each council year Political leaders should meet with the Standards Committee to agree the following:

- How Group Leaders and the Standards Committee would work together to ensure appropriate standards of behaviour (with a pre-agreed pro-forma completion process on an annual basis),
- Frequency of meetings between Group Leaders and the Standards Committee throughout the year (pre-agreed every six months; next being December 2024),
- The threshold which the Standards Committee would use to establish whether it was content that Political Group Leaders had complied with the duties of the 2021 Act (as set out in the Standards Committee Annual Report), and
- The mechanism for Political Group Leaders to provide reports to the Standards Committee about the actions they had taken to comply with the duties within the 2021 Act (via the amended pro-forma contained at Appendix A of the report).

Therefore, as the first meeting of the new municipal year, all four Group Leaders were invited and were present at the meeting to make comment under Part II of the meeting and had kindly completed the necessary pro-formas that were also contained within the Part II agenda papers.

With the Committee's agreement, the Chair subsequently moved the meeting into Part II.

96 GROUP LEADER PROFORMAS FOR CONSIDERATION BY STANDARDS COMMITTEE (MO/HLDS) (EXEMPT INFORMATION – PARAGRAPHS 12, 13 AND 14) –

All four Political Group Leaders were invited and were present at the meeting to make comment on the duties placed upon them in line with Section 52 of the Local Government 2000 Act as amended by section 62 of the Local Government and Elections (Wales) Act 2021.

The mechanism being that Political Group Leaders provide reports to the Standards Committee, on an annual basis, using a pre-agreed code of conduct compliance pro-forma, about the actions they had taken to comply with the aforementioned duties.

All four Political Group Leaders had submitted completed pro-forma in advance of the meeting and were provided with the opportunity to address the Committee in turn.

Once each of the Group Leaders had addressed the Committee, and Standards Committee Members posed their related questions, all Political Group Leaders were asked to vacate the meeting so that the Standards Committee could deliberate in private based on the threshold criteria on the role of a Political Group Leader in the Vale of Glamorgan Council, as set out in Appendix B of the Part I report.

Having regard to Standards Committee discussion in private deliberation, it was subsequently

RESOLVED – T H A T the Scrutiny Committee Annual Report be amended to reflect the Committee's satisfaction, following assessment, that the statutory duties placed on Group Leaders have been met.
